CSF- VARESE PROVINCE WILDBOAR ERADICATION PLAN
(SUMMARY)

INTRODUCTION

An outbreak of CSF in domestic pigs occurred in the province of Varese in date 14.05.97 (97/17). After this date there have been 2 outbreaks in domestic pigs and 9 outbreaks in wild boar. In the protection zone of outbreak 97/17, 40 wild boar were found dead, 12 of them were positive for CSF. Due of this situation and under the provision of the Directive 80/217/CEE, an infected zone for wild boar was established.

This infected area is delimited by natural barriers and it is covered mainly by forest. (See map 1).

CHAPITRE 1 : INFECTED AREA

1.1. Delimitation of the infected area

The infected area is 10824 hectares and included all the municipality where the wild boar were found positive for CSF.

Wildboar find positive for CSF: Municipality of Casalzuigno (10), Brenta (1) and Laveno Mombello (1). This municipality are into the PZ for CSF in domestic pigs.

The infected area is delimited of natural barriers (see point 1.4).

1.2. Wildboars population in the infected area.

Due of the territory conformation (woodland) is not possible to take a normal census of the wild boar population. Therefore, (1994) a statistical calculation was carried out using the animals shoot killed.

The actual valutation is about 450 heads.

1.3. Distribution of the disease in the infected area.

Municipality of Casalzuigno, Brenta and Laveno Mombello.

1.4. Barriers around the infected area.

West: Lago Maggiore

East: Margorabbia river

Others barriers are represent by the roads around the infected area were there is an intensive traffic.

1.5. Number of domestic swine holdings in the infected area.

56 familiarly holdings with 300 pigs.

CHAPITRE 2 : MEASURE CARRIED OUT TO DETECT THE INFECTION IN WILD BOARS.

2.1. Surveillance programme

Since 4 years there is an informative sistem to notifie when a wildboar is shooted or found dead in the year.
The wildboar are bring to the Luino slaughterhouse with the specific card and with the special registration.
In the slaughterhouse samples are collected (organs and other material) and they are sended to the Varese IZS for the laboratory control.

2.2. Laboratory test

- screening in Elisa/AG on the homogenized organs (IZS Varese)
- screening on blood samples (IZS Varese)
- immunofluorescence on organ cryostatic sezions (IZS Brescia)
- specific serological confirmation for Ab PSC after the first positivity (IZS Brescia).
- sowing of the homogenized in cellular culture (PK 15) (IZS Brescia and Perugia))
- PCR (CRPS Perugia)

CHAPITRE 4 : CONTROL OF THE WILD POPOLATION

4.1

4.2. First measure in the infected zone

Objective: to avoid the diffusion of the disease out the infected zone

- ban to train the hunting dogs (also in authorized dog-loving zone);
- proibition of using wildboar pastura point that are not natural;

- ban of wildboar breeding;
- ban to utilize, for food and feed, the wildboar killed or found dead;
- obligation to signal all the wildboar found dead and to send the organs for the control at IZS.

4.3. Measure carried out during the hunting season.

The surveillance system and shoot regulation meet the following requirements:

Measure in the infected zone;

- recognition of appropriate shooting period and permanent information and education for the hunters;
- recognition of appropriate of shoot extra period or killed plan under the following principles:

- a) killed plan without to consider the wildboar features (age, sex, etc) or zone under specific respect;
- b) centripetal direction of shoot;
- c) ban to slaughter the wildboar in sited;
- d) obligation to send the wildboars to the Luino slaughterhouse and meat-stopped until the results of the test;
- e) destruction of the internal organs

Last outbreak on October 1997.

Origin of disease: hypothesis:

- a) illegal introduction of wild boars in the first period of the years;
- b) animals waste.

1.1. DISEASE PREVENTION

- 1.1.1 stamping out in the outbreaks and disinfections;
- 1.1.2. killed and destruction of the pigs seropositive and the other pigs in the holding;
- 1.1.3. complete stand still;
- 1.1.4. ban of introduction in the holding of meat wildboar or other part (bone, etc);
- 1.1.5. ban of administration of animals waste;
- 1.1.6. veterinarians control in the infected holding zone;
 - 1.1.6.1. clinical control
 - 1.1.6.2. serological control;
 - 1.1.6.3. identification of risk points;
 - 1.1.6.3.1. enclosure
 - 1.1.6.3.2. huntings present

1.2. MOVIMENTATION OF THE DOMESTIC PIGS IN THE INFECTED ZONE

1.2.1 Into

- Stand still
- Specific authorization to send animals to slaughterhouse
- Virological test after the slaughter

1.2.2. Out

- 1.2.2.21. no possible to send pigs to other Member State
- 1.2.2.2.- possible to move the breeding pigs after the serological test on at least 2 pigs for group within 10 days before the movementation.
- 1.2.2.3. clinical control for to move the slaughter pigs.

1.3. OTHER MEASURE

Control and regolamentation of the familiary slaughtered with ante and post mortem inspection and serological control.

CHAPITRE 7: REVOCATION OF THE RESTRICTION IN THE INFECTED ZONE

7.1. Domestic swine holdings

- 6 mounths after the last outbreak in the wildboar

7.2. Wildboars

Serological monitoring for 3 years after the last outbreak.
